- Protection of the rights and interests of pharmaceutical companies and health organizations

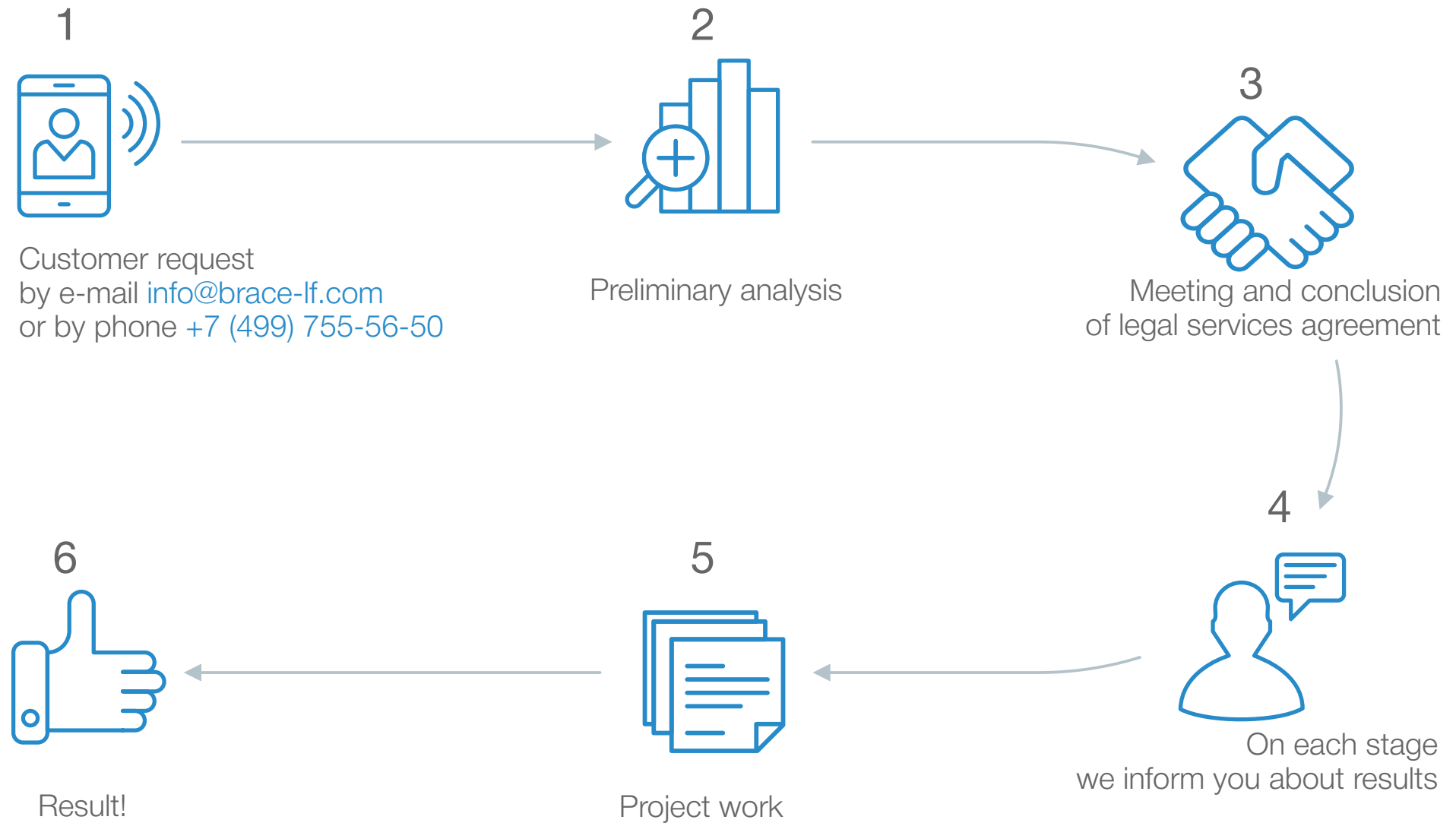
