- Appealing the entry of the company in the Register of Unfair Suppliers



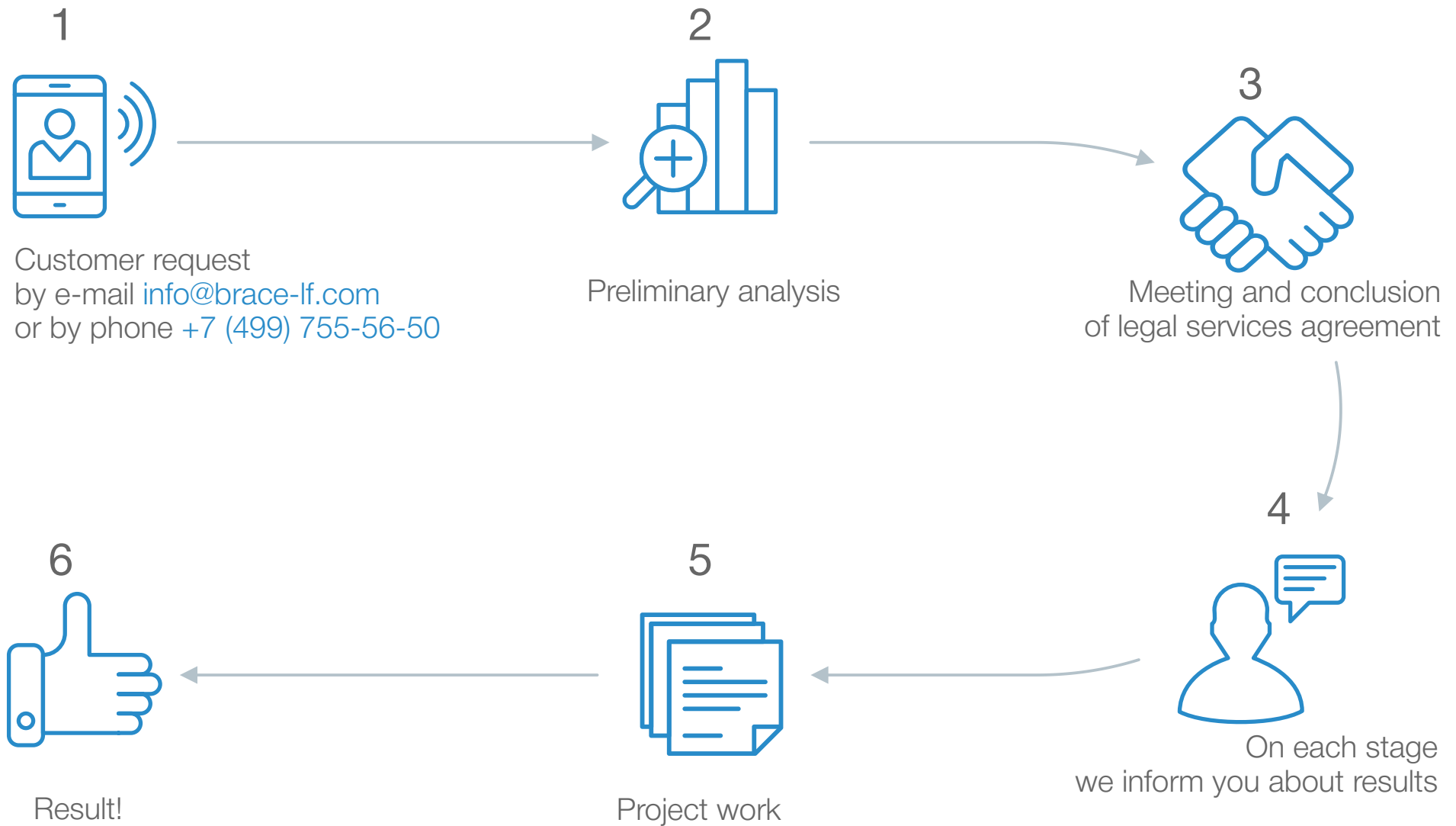
Training
